2017-09-01	It's now possible to copy a site for the complete configuring	<p>It's now possible to copy a site and including copy of the complete configuring. This means that all parameters found in the java-client screen Own Site in are copied.</p> <p>Copy can be done in both with the web client and the java client. In the web client is copy done in the Own Site screen and here is possible to update attributes such as name, contact info and email notifications directly. In the java client is copy done in Business detail screen. Here it not possible to update attributes like name, contact info and email notifications directly, but it can be done in the Own Site screen after creation of the new site.</p> <p>Note that all applictaions found in the copied site will be copied and unlocked in the new site. The user must have priveledge System Administrator to be allowed to create a new site.</p>
2017-09-01	It's now possible to add partner agreements and and update adress and contact info ffor a supplier or customer in the web client	It's now possible to add partner agreements and update address and contact info for a supplier or customer in the web client. The user must be either sys adm or be a user with role supplier/customer to have privilege to updated the supplier or customer.
2017-09-01	It's now possible to add partner agreements and update address and contact info on a site	It's now possible to add partner agreements and update address and contact info on a site. This for both supplier partner agreements and customer partner agreements. The user needs at least Site Administrator privilege to be able to add partner agreements and configuring privilege to update address and contact info.
2017-09-01	Some Time Zones are no longer avaiable to select	<p>We have removed some time zones, so they no longer are available to select.</p> <p>There were technical problems with the definition of some time zones. Notably for the Baltic states, where (GMT+02:00) Europe/Helsinki is a good alternative.</p>
2017-08-31	In the Performance Report screen 'Totals', Forecast Bias Order is computed incorrectly	The computed value did not match the values in the 'Lines' or the 'Graph'. The error was corrected.
2017-08-31	User session's time zone	<p>A user's session will keep the same time zone, even when changing to a site that normally uses another time zone.</p> <p>User can select a personal time zone in the User Settings screen.</p>

2017-08-30	Two error corrections in a 'Cancel Reception' case	<p>It is possible (but rare) to use a setup where the Reception Registration (CS06) transaction tries to match the received quantity with the available deliveries.</p> <p>If quantities do not match exactly, one delivery will be split into a new received (finished) delivery with the remaining quantity on the old delivery.</p> <p>These errors occur when such a split needs to be undone because of a Cancel Reception (CS47) transaction.</p> <p>1 - after 'split' and 'cancel', the remaining quantity could be too low. The difference would be the received quantity of the split (finished) delivery.</p> <p>2 - after 'split' and 'cancel', a subsequent 'split' could fail with error message "Duplicate. We already have such a record."</p> <p>Both errors were corrected.</p>
2017-08-23	Change in background job 'Create Order From Forecast'	<p>The background job 'Create Order From Forecast' locates forecast within the Confirmation Horizon and converts them automatically to orders and order lines.</p> <p>It used to create one order per supplier and site. Now it also separates order lines with different Receipt Dates into distinct orders.</p>
2017-08-21	Two errors in use case "Undo Service Level Error"	<p>In PipeChain Analyzer, the Service Level KPI (Key Performance Indicator) is computed and saved daily for each Delivery Agreement.</p> <p>Sometimes it is desirable to "change history", i.e. when the supplier was not at fault for some external reason.</p> <p>Thus "Undo Service Level Error" can be performed</p> <ul style="list-style-type: none"> <li>- by an admin user - from the "Performance Report" screen in the PipeChain Client.</li> </ul> <p>This could fail for two independent reasons</p> <ul style="list-style-type: none"> <li>- an internal error stating "Invalid object name 'UserProfile'."</li> <li>- a conversion error when the user used any "locale" with non-ISO date format, stating "String out of bounds".</li> </ul> <p>Both errors were corrected.</p>
2017-08-17	Allow changes to a "shipment" by using Delivery Note Id	<p>This function is useful when shipping without using a Despatch object.</p> <p>If a shipment needs to be changed, the new use case "Change Shipment..." can be applied to any shipped (but not received) Inbound Delivery, and the changes are applied to all Inbound Deliveries with the same Delivery Note Id (SiteKey, supplier keys and Delivery Type must also match).</p> <p>The choice is available if Selected Property 39 "Allow change of shipped Inbound Deliveries with the same Delivery Note Id (Admin required). Default: false." is set.</p>
2017-08-17	If an Inbound Delivery has multiple Notes, it will be displayed multiple times in the grid screen	<p>Affected PipeChain client screens Inbound Delivery and Inbound Delivery Suggestion, and probably also web screens.</p> <p>Luckily, Notes are not widely used.</p>

2017-08-15	Delivery agreements was not always create when confirming an order with sub order type Agreement Order or Agreement Option Order	Delivery agreements should be created when an order of type Agreement Order or Agreement Option Order. This was not the case always as processing stopped deu to errornous handling of transaction conflict.
2017-08-07	No block of supplier forecast calculation	There is no need on having the block supplier forecast calculation function any more. It was designed for blocking simultaneous calculations when many customers were calculated. Now it seems unstable and we decided to not set the block at all and we see no risk on not having any block.
2017-08-02	Handle HTML in radio buttons correctly in despatch package instructions.	Handle HTML in radio buttons correctly in despatch package instructions. Earlier the HTML escaping failed and the HTML was shown in the view.
2017-07-31	Order status remain in status "Change Requested" after confirm	Order status remain in status "Change Requested" after confirm, it should be updated to status "Confirmed". This was the case when either "customer change" flag is set even if there are no real changes or when pressing button "Keep previous confirmed values" in "Customer has change the order" dialog.
