Added Inbound and Outbound Performance Report to the list of displayable views in the Dashboard.
2017-11-10	All Invoices screen was very slow for some suppliers	All Invoices screen now takes into consideration that not all invoices have connections to despatches, thus speeding up the database query significantly.
2017-11-09	Delivery Suggestions: buttons for Generate and Delete Delivery Suggestions were missing	Added button for Generate Delivery Suggestions in screens Customer Product Duration Meter, Customer Product and Delivery Planner. Added button for Delete Delivery Suggestions in screen Partner Agreements. Enabled context menu action Generate Delivery Suggestions for site admin role in Java Client screen Delivery Agreement Overview.

This occurred for order lines in status "Suggestion" that also had a "Late Shipment" remark.
2017-11-08	Inbound Order - Better performance when exporting to Excel	When exporting Inbound Orders to Excel, the columns displaying the number of lines with Red and Yellow Alerts are no longer included. This will dramatically reduce the time for large exports.

If recurrence is more than one week, this also requires that a Start Date is chosen (any date in any start week will do).</p> <p>Recurrence and Start Date are configured in screen "Reception Schedule Detail", tab "Weekly Transport".</p> <p>This data is also displayed in tab "Transport List" (and the number of generated transports is affected accordingly).</p> <p>Presence of multi-week recurrence is visible in screens "Reception Schedule Overview" and "Delivery Agreement Overview". These columns have a very large impact on the performance of the screen. The columns are no longer visible by default. Note that at confirm CS05 will be used as normal confirmation, though normal deviations will not be applied.
